THROUGH THE CAMPAIGN, MLI RAISES PRIVATE FUNDING TO PROVIDE HIGHLY TRAINED MDDS TO "SNIFF OUT" LANDMINES AND TO SAVE AND IMPROVE LIVES IN SEVERELY CONTAMINATED, WAR-TORN COUNTRIES. MLI ALSO TRAINS LOCAL HANDLERS TO SAFELY AND EFFECTIVELY INTEGRATE THE MDD TEAMS INTO NATIONAL LANDMINE CLEARANCE PROGRAMS.
